7. New Business

a) Complaint: Schulz said a written complaint from a Forest Home Township resident had been included in the council packets for the March meeting. The complaint concerned Village of Bellaire Police Officer Drollinger. Council referred the issue to the Administration and Personnel committee.

Schulz said he'd discussed the issue with legal counsel. He said counsel's recommendation was to investigate as thoroughly as possible and to take the complaint seriously, even though the complaint is a third party report. Schulz said he'd also discussed the complaint with Chief Rowe and would like to get the committee's consensus on how to proceed.

The complaint states that a discussion took place, the allegation being that something inappropriate was said during the discussion. Chief Rowe said he's more than happy to interview the people who were present. He added that even if the allegation were true, that nothing criminal took place. He said that if an allegation of that nature were proved

to be true, the officer could be suspended for a period of time without pay and a letter would be placed in the officer's personnel file. Chief Rowe will conduct the interviews and present a report to the committee.

Schulz said since the village has engaged legal counsel for advice regarding the issue, he requested that Koch ask the village attorney if records created during the investigation is subject to attorney-client privilege and therefore not FOIA-able.

The requirements of closed meetings as part of the Open Meetings Act were discussed. Schulz requested that at the end of the investigation, that a letter be crafted to the original complainant with the investigation's results. Chief Rowe said he will do his best to find the truth and present it to the complainant.

- **b) FOIA Policy:** The committee packets contained the village's current FOIA policy and accompanying forms. The documents will be discussed at a future committee meeting.
- c) Various Matters As Appropriate: Schulz mentioned that a letter to Councilman Denny Balon had been sent. The letter mentioned his recent absences from council and committee meetings and asked his intentions regarding his council seat. No reply has yet been received.
