The Pavilion will be considered reserved upon payment of the \$50.00 fee and the signatures of both parties. The Pavilion will not be reserved over the telephone.

1. You must be 21 years old to make a reservation. A copy of state issued identification is required.
2. Pick up key for gate, electrical box, tables, and fireplace at Village office. Potable water is available at the Pavilion. All tables must be chained and locked at the end of the day. All locks must be locked at all times.
3. No glass containers are allowed in the park, except pursuant to a permit issued under Chapter 75, Article I § 75-2 A. of the Code of the Village of Bellaire
4. Except as provided in Chapter 75, Article I § 75-2 of the Code of the Village of Bellaire, alcohol is NOT permitted in the park. Per Chapter 75, Article I § 75-2, an application for permit for the possession and consumption of alcoholic liquor is available from Bellaire Police Chief.
5. Absolutely no vehicles in the park without a permit from the Village of Bellaire.
6. All garbage is the responsibility of the Renter. **Bag and remove all garbage from the park.**
7. The key must be returned on the next regular Village working day.
8. Excessive noise (band, etc.) shall cease at 9:45 P.M.
9. The person making the reservation understands they are responsible for seeing the aforementioned rules are observed and by signing above agrees to all stated rules.
9. The key deposit is refunded after the key is returned and park is cleaned.
